I hereby agree to participate and/or engage in the use of the course, equipment, facilities and programs offered by the Club upon the understanding and agreement that:

1. I am aware of the risks of illness or injury inherent in any golf or exercise activity. These injury risks include, but are not limited to: being hit by golf balls, golf clubs, golf carts, or lightning; stepping or tripping in holes or other natural indentations in the ground; injury from insects, animals, birds or snakes, drowning; pulled muscles or other sprains, strains or injuries. I am participating in the Club's programs upon the express understanding that I hereby indemnify, defend, waive and release the Club, its employees, agents, officers, Directors, Successors, and Assigns from any and all claims, costs, liabilities, expenses or judgments, including attorney's fees and court costs (hereafter referred to as the "Claims") arising out of my participation and the participation of my family and guests in the program(s) or any illness or injury resulting there from, and hereby agree to indemnify and hold harmless the Club from and against any and all such Claims defend, indemnify and hold harmless.

2. Twin Village Golf Course and facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of Twin Village Golf Course. Certain private and public events may dictate that the golf course, practice areas, clubhouse and/or other areas of Twin Village Golf Course be closed. Member understands and agrees that nothing in this Membership Agreement shall entitle member to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facility and the clubhouse and other privileges and benefits may be limited by Twin Village as necessary. No member is entitled to a refund or return of amounts due to damage to or condition of the golf course or any amenity. Further, Twin Village Golf Course shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond control of Twin Village Golf Course.

Events & Outings

An annual Member who plays in an outside golf event or tournament will be subject to the applicable green fee associated with said event. At times, there will be club-organized events in which The Club will allow Member to use their pass in lieu of a designated green fee. Outside events are not limited and at the sole discretion of Club management. Outside events may require course closure.

Private Golf Cars and Trail Fee

All privately owned golf cars will need to be approved for use on Twin Village Golf Course by management, and will need to provide a certificate of insurance. All privately owned golf carts must display the appropriate decals. Only approved golf cars will be allowed on the golf course during an appointed round. No Golf cars will be allowed to use the cart path before dusk or before dawn.
